

KUBOTA ENGINE AMERICA CORPORATION LIMITED WARRANTY ON REMANUFACTURED ALTERNATORS AND STARTERS

OUR WARRANTY TO YOU

We warrant to you, the original purchaser, that all parts of your Kubota Engine America Remanufactured Alternator and/or Starter purchased from an Authorized Kubota Industrial Engine Distributor or Dealer in the United States will be free from defects in materials or workmanship for a period of 12 months from date of purchase.

WHAT WE WILL DO

We will, at our option, repair or replace any part covered by this warranty which becomes defective, malfunctions or otherwise fails to meet the conditions of this warranty under normal use and service during the term of the warranty at no charge for parts only. Labor will not be covered under this warranty for any reason.

WHAT YOU MUST DO TO OBTAIN WARRANTY SERVICE

In order to obtain warranty repairs, you <u>must</u> deliver the product, together with proof of purchase, to an Authorized Kubota Industrial Engine Distributor or Dealer at your expense. All warranty claims for Kubota Engine America Remanufactured Components <u>must</u> be submitted by the Kubota Industrial Engine Distributor using the **Remanufactured Parts Warranty Request Form** and include the following mandatory information: Kubota Engine Model, Engine Serial Number, Hours of Use, Date Sold, Fail Date, and Repair Date.

WHAT THE WARRANTY DOES NOT COVER

This warranty does not cover:

- 1. Damage, malfunctions or failures resulting from accidents, abuse, misuse, modifications, alteration, improper servicing, or lack of performance of required maintenance service.
- 2. Installation of replacement parts.
- 3. Non-genuine Kubota Remanufactured Parts.
- 4. Damage caused by water entering the Remanufactured Component due to any cause.
- 5. Used Products.
- 6. Any damage caused by overheating that is not a direct result of a defect in materials or workmanship. Kubota further limits coverage to the Remanufactured Component only.
- 7. Remanufactured Components installed on non-Kubota Engines.
- 8. Remanufactured Components sold outside of the United States.
