



**KUBOTA ENGINE AMERICA CORPORATION
LIMITED WARRANTY ON GL7000 AND GL11000 GENERATORS
AND REPLACEMENT PARTS IN CANADA, EFFECTIVE NOVEMBER 1, 2015**

OUR WARRANTY TO YOU

We warrant to you, the original purchaser, that all parts of your new Kubota **GL7000** or **GL11000** CSA approved (blue units) diesel generator and replacement parts purchased from an Authorized Kubota Generator Distributor or Dealer in Canada will be free from defects in material or workmanship during the following periods from date of retail sale.

1. Diesel engine and generator components for 3 years or 3000 hours, whichever occurs first for all parts and labor from the date of retail sale to you.
2. Replacement Parts for 90 days from the date of installation; or the remainder of the part warranty, whichever is longer.

WHAT WE WILL DO

We will, at our option, repair or replace any part covered by this warranty which is defective, malfunctions or otherwise fails under normal use, during the term of this warranty, at no charge for parts or labour as indicated in the appropriate flat rate manual.

This warranty does not cover charges for transportation and service calls.

WHAT YOU MUST DO TO OBTAIN WARRANTY SERVICE

In order to obtain warranty repairs, you must deliver the product, together with proof of purchase, to an Authorized Kubota Generator Distributor or Dealer at your expense. The names and addresses of Authorized Kubota Generator Distributors and Dealers may be obtained by contacting **Kubota Engine America Corporation**.

WHAT THIS WARRANTY DOES NOT COVER

This warranty does not cover;

1. Defects, malfunctions or failures resulting from accidents, abuse, misuse, modifications, alterations,

- improper servicing or lack of performance of required maintenance service.
2. Normal maintenance service or replacement of maintenance items such as injector tips, glow plugs, indicator and resistance coils, filter elements, lubricants, belts, oils and coolants, etc.
3. Premature wear, etc. resulting from incorrect application of product.
4. Installation of replacement parts unless originally installed by an Authorized Kubota Generator Distributor or Dealer.
5. Natural calamities such as earthquake, storm, flood, fire, etc.
6. Transportation and service call charges.

THIS IS THE ONLY EXPRESS WARRANTY ON OUR PRODUCTS

Kubota Engine America Corporation does not authorize any other party, including Kubota Generator Distributors or Dealers, to make any representation or promise on behalf of **Kubota Engine America Corporation** to modify the terms, conditions or limitations of this warranty in any way.

LIMITATIONS ON OUR RESPONSIBILITY FOR OUR PRODUCTS

Our warranty is to repair or replace defective parts as stated above. We will not be responsible for any other expenses, losses or inconvenience which you may sustain as a result of the purchase, use, or operation of our products. Our responsibility for any and all losses and damages resulting from any cause whatsoever, including our negligence, alleged damage or defective goods, whether such defects are discoverable or latent, shall be limited to the repair or replacement of defective parts as stated above. In no event will we be liable for loss of use, loss of profits, loss of or damage to related equipment, inconvenience, commercial loss or other incidental or consequential damages whatsoever. Some Provinces may not allow limitations on express warranties or implied warranties or the exclusion or limitation of incidental or consequential damages, so the above limitations or exclusions may not apply to you.
